Two Polling Sites Moved in Hall County

Grand Island, NE – Hall County Election Commissioner Tracy Overstreet announced Tuesday that two new polling places will be in place for the May 15, 2018 Primary Election. The polling site at Westridge Middle School has been moved to Third City Christian Church, 4100 W. 13th St., and the polling site at Grand Island Senior High has been moved to the United Veterans Club, 1914 W. Capital Ave.

"These two moves were made for voter convenience," Overstreet said.

"Third City Christian Church has a brand new community center and the United Veterans Club has long been used for large gatherings," Overstreet said. "Both of these new sites have ample parking, handicapped access and less traffic congestion that is found around schools."

More than 3,100 voters will be affected by this change – more than 1,800 will now vote at Third City Christian Church and more than 1,300 who will vote at the United Veterans Club. Notices are being mailed to voters this week informing them of the change. Each of the voters in those two polling sites will receive a new voter identification card that lists the voter's address, party, precinct number, races in that precinct and the new polling site.

"This move should be a win-win for everyone involved," Overstreet said. "We thank the school system for its generous use of school space in past years, and of its continued support in those areas where schools are still being utilized as a polling site. We also thank our community partners at Third City Christian Church and the United Veterans Club, as well as the 20 other sites across Hall County that are used as polling sites on Election Day."
