<div>Primary election filing deadlines: Filing deadline for incumbents is February 15, 2024 Filing deadline for non-incumbents is March 1, 2024</div> <div>General election only filing deadlines: Filing deadline for incumbents is July 15, 2024 Filing deadline for non-incumbents is August 1, 2024</div> <div>Some races may not appear on the primary election ballot if the number of candidates filing for office did not exceed twice the number of vacancies. For example, a "Vote for one" office with one or two candidates will not appear on the primary election ballot. However, if three candidates are running for the "Vote for one" office," all three will be on the primary ballot because there is more than two times the vacancies (Vote for one times 3 candidates = 3. Maximum number of finalists based on double the number of vacancies is Vote for one times 2 = 2.)
