School Dist. 82 Bond Issue

Shall Hall County School District 082 (aka Grand Island Northwest High School), in the State of Nebraska, issue the Bonds of the District in the principal amount of not to exceed Four Hundred Seventy-Five Thousand Dollars (\$475,000) for the purpose of paying for repairs to and equipment and apparatus for the existing High School building, said bonds to bear interest at a rate or rates to be determined by the Board of Education and to become due at such time or times as may be fixed by the Board of Education, provided, however, that any or all of said Bonds shall be redeemable at the option of the District at any time on or after five years from date of issue, and

Shall the District cause to be levied and collected annually a special evy of taxes against all the taxable property in the District sufficient in rate and amount to pay the interest and principal of said Bonds as the same become due?

Proposed Amendment No. 1 - Special

A constitutional amendment to separate tangible personal property from the uniform and proportionate provision applicable to real property, to provide for the valuation of taxable tangible property at depreciated cost or at actual value uniformly and proportionately, to provide for the separate classification of property and franchises protected by federal law, to harmonize a provision relating to the limitation on county taxes, and to provide that legislation passed in the regular 1992 legislative session shall be effective January 1, 1992, and is ratified and confirmed by this agreement.
